

Terms & Conditions – Home Improvement Voucher Competition

1. Promoter

This promotional competition (“Competition”) is organised and conducted by [Cuyler Butchery / Bucu], in association with BUCO and Cuyler stores participating in the Competition.

2. Competition Period

The Competition will run from 18 May 2026 and closes at 23:59 on 10 December 2026 (“Competition Period”).

No late entries will be accepted.

3. Eligibility

3.1 The Competition is open to all legal residents of the Republic of South Africa who are: 18 years or older at the date of entry; and

in possession of a valid South African ID, passport, or legal residency permit.

3.2 Directors, members, partners, employees, agents, consultants, suppliers, and immediate family members of the Promoter, BUCO, Cuyler, and any associated agencies are not eligible to enter.

4. How to Enter

4.1 To qualify for entry into the Competition, participants must:

spend R2 000 (two thousand rand) or more in a single transaction at any participating BUCO or Cuyler store during the Competition Period; and
complete and submit an official competition entry form at the store where the qualifying purchase was made.

4.2 Each qualifying transaction entitles the participant to one (1) entry.

4.3 Multiple entries are permitted, provided each entry is linked to a separate qualifying purchase and valid proof of purchase.

4.4 Participants must retain their till slip or invoice as proof of purchase. Failure to provide valid proof may result in disqualification.

5. Prizes

The following prizes are available to be won:

1st Prize: Home Improvement Voucher to the value of R50 000

2nd Prize: Home Improvement Voucher to the value of R30 000

3rd Prize: Home Improvement Voucher to the value of R20 000

6.3 Winners will be contacted telephonically using the contact details provided on the entry form.

6.4 If a winner cannot be contacted within 7 (seven) days, or fails to provide required documentation, the Promoter reserves the right to disqualify that winner and select an alternative winner.

7. Prize Collection

7.1 Winners may be required to collect their prizes from the participating BUCO or Cuyler Butchery store where they entered.

7.2 Winners must present:

a valid South African ID/passport/residency permit; and
the original proof of purchase corresponding to the winning entry.

8. Publicity and Marketing

By entering the Competition, participants agree that the Promoter may use their name, image, and/or photograph for publicity and marketing purposes related to the Competition, without additional compensation, unless the participant expressly declines such consent.

9. General

9.1 The Promoter reserves the right to amend, suspend, or terminate the Competition and these Terms & Conditions at any time, without prior notice, if deemed necessary.

9.2 The Promoter shall not be liable for any loss, damage, or injury arising from participation in the Competition or acceptance/use of any prize.

9.3 Any participant found to be tampering with the entry process or acting fraudulently will be disqualified.

9.4 The Promoter's decision regarding any aspect of the Competition will be final and binding, and no correspondence will be entered into.

9.5 By entering the Competition, participants acknowledge that they have read and understood these Terms & Conditions and agree to be bound by them.
